

**RULES AND REGULATIONS OF
A-1 Central Park Resident's Welfare Association,
Safdarjung Enclave,
New Delhi – 110029**

1. MEMBERSHIP

The membership of the Society is open to any person of any origin who has attained the age of a majority and fulfils the terms and conditions of the Society, without discrimination of religion, caste, colour or creed, but subject to the approval of the Governing Body if the membership is refused to a certain person, refusal shall be communicated to the person concerned.

2. SUBSCRIPTION

Quarterly payment of Rs. 1500/-, and any other payment as may be authorized by the Governing Body.

3. TERMINATION OF MEMBERSHIP

The Governing Body shall have the power to expel a member from the society on the following terms and conditions:

- (i) On his / her death.
- (ii) Non-payment of subscription continuously for more than three months from due date.
- (iii) On his / her written resignation.
- (iv) He / she has not attended three consecutive meetings of the General Body without any intimation.

4. APPEALS

All the appeals should be preferred by the General Body of the society, the decisions of the General Body shall be final. The reason for rejection shall be communicated to the person concerned.

5. READMISSION

In case of member expelled by the General Body, the same can be readmitted provided the member concerned pays and upto date due the decision of the General Body shall be final.

6. GOVERNING BODY

The Governing Body shall consist of all members and office bearers as under:

- 1. President
- 2. General Secretary
- 3. Treasurer

7. BANK ACCOUNT

The Bank Account of the Society shall be operated by the Treasurer General along with, either the General Secretary or the President.

8. GENERAL BODY

Constitutes all the members of the society which constitute the General Body.

9. Function Of The General Body

- (i) To consider any business brought forward by the General Body.
- (ii) There shall be an Annual Meeting of the General Body in the month of March every year.
- (iii) Not less than 15 days notice shall be given to members before the date of General Body meeting enclosing the agenda specifying date, time and place.

10. SOURCE OF INCOME

- (i) Admission Fee
- (ii) Subscription
- (iii) Donations and Special Contributions
- (iv) Advertisements

11. GOVERNING BODY

The Governing Body's strength shall not be less than 7 and not more than 21. The members of the Governing Body shall hold the office for three years. The meeting of the Governing Body shall hold the office as and when necessary for which 15 days clear notice will be required and quorum shall be 2/3rd.

12. ELECTION

The General Body in the annual meeting will elect its President and all the office bearers and members after three years, by secret ballot system. The quorum of the General Body and Governing Body shall 2/3rd.

13. FUNCTIONS OF THE GOVERNMENT BODY

To arrange, finance if required from other Bank(s) institution or individual on reasonable terms and conditions and the Governing Body as a whole is liable for its return.

14. AUDIT

The Account of the society shall be audited at least once a year by an auditor appointed by Governing Body.

15. FINANCIAL YEAR

The financial year of the Society shall start from the 1st day of April to 31st day of March every year.

16. TENURE

The tenure of the Governing Body shall be for three years

17. AMENDMENT

Alternation, extension or change in aims and objectives or change of name will be done under Section 12 and 12-A of S.R. Act of 1860 as applicable to the Union Territory of Delhi, the amendment in the Memorandum shall made under this Section.

LEGAL PROCEEDING (SECTION 6 OF THE ACT)

The Society may sue or be sued in the name of the President as per Provisions laid down under Section 6 of the S.R. Act 1860 as applicable to the Union Territory of Delhi.

ANNUAL LIST OF GOVERNING BODY

Once in every year a list of the Office Bearers and member of the Governing Body shall be filed with the Registrar of Society, Delhi as required under Section 4 of the Societies Registration Act 1860 as applicable to the Union Territory of Delhi.

DISSOLUTION

If the Society needs to be dissolved it shall be dissolved as per provisions laid down under Section 13 & 14 of the S.R. Act 1860 as applicable to the Union Territory of Delhi.

APPLICATION OF THE ACT

All the provisions under the Section of the Societies Registration Act 1860 as applicable to the Union Territory of Delhi shall apply to the Society.
